Current families will go to the Parent PlusPortal to register and new families will go to [www.faithacademy.us](http://www.faithacademy.us) to register and create a FACTS account: create login, add your child(ren), and select a payment plan. Please remember that your child's enrollment will **not** be complete until you have completed the FACTS enrollment process. There will be an enrollment fee of either \$20 or \$50 per family, based on your chosen payment plan.

- Any payment not processed due to non-sufficient funds will incur a \$30 NSF fee.
- Report cards will be held and/or transcripts will not be forwarded to other schools or colleges until all accounts are paid in full.
- All prices are subject to change without advance notice.

  - Upon registration: Registration and building fees are due.
  - First month's tuition is due by June 10.
  - All fees and tuition must be paid on due dates to keep your child's/ children's place secure.
  - All fees and tuition are non-refundable.
